Visa Requirements for MALAYSIA

All cruising guests can disembark/embark from Malaysia except for below country require visa.

Shorex

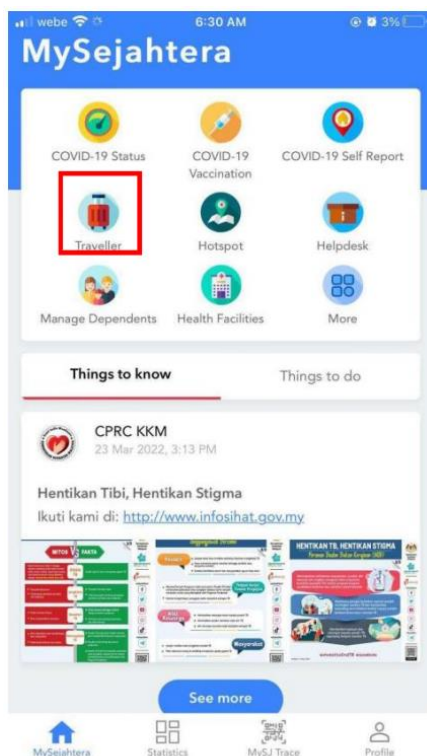
- No visa requirement for going Shorex (For all except Israel citizen)

SOP for Passengers to go Ashore in Malaysia

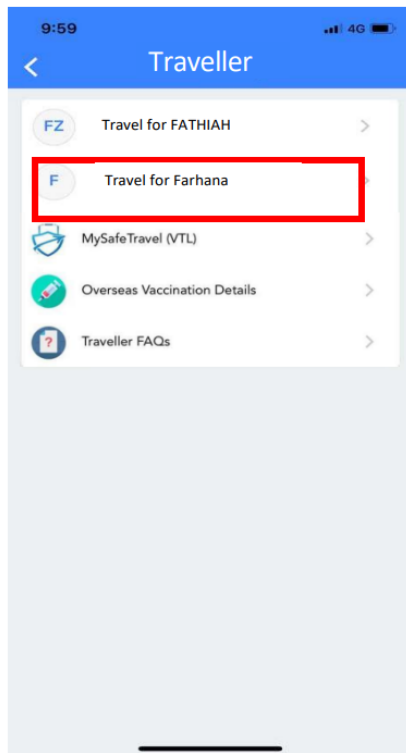
- The process starts with “traveller application” through MYSEJAHTERA apps (refer to GUIDELINE below).
- Guest must declare all the details required in the apps along with vaccination status.
- Once details are filled up in MYSEJAHTERA apps, traveller’s card will be issued electronically from the apps.
- There are two types of traveller’s card “Blue” and “Red” where blue card means guest will be allowed to go ashore in Malaysia, while red means otherwise.
- Only guest with status fully vaccinated (2 doses and some vaccine type will require booster) is allowed to go ashore in all Malaysian Ports.
- Please refer attached Malaysian MKN SOP for further vaccination guidelines for reference (pg. 18).
- Guest is encouraged to have their passport copy either hardcopy on in their phone for identification while in Malaysia (passport will be kept in Port Immigration office when vessel is in Port).
- Guest is encouraged to adhere to regular covid-19 SOP such as mask, social distance, sanitizer, etc.
- Malaysian Port Health will station health officers in every cruise terminal entry point to check on all above requirement randomly (hence to advise guest to adhere accordingly).


1. Click on Traveller Icon
